6. A candidate may withdraw his/her nomination in writing until 12 November 2012 (midnight).

7. Sealed nomination Form and withdrawal letter should be delivered in person to the Chairman of the Election Committee or mailed to the address given below. Any mail received after the stated deadlines will not be accepted.

11. In case of multiple nominations for the same post, the election committee will conduct election through secret ballot. The election results will be decided on a simple majority vote of the members.
